2021 Advance Child Tax Credit Questionnaire

- In lieu of this worksheet, please provide <u>IRS Letter 6419</u> to me if you have it in your possession. It should have been mailed to you by the IRS in Dec. or Jan. to confirm the amount of Advance Child Tax Credit ("CTC") issued.
- The 2021 Advance CTC was an *advance tax credit* for your 2021 tax return. The monthly payments were based on dependent data from your 2019 or 2020 tax return, depending on which year the IRS had available to them for reference.
- If you were eligible, but for some reason did <u>not</u> receive the advance payments, you will now receive them as a refundable tax credit on your 2021 tax return.
- If you did not receive a full or partial payment due to income limits, that situation may continue to disqualify you for 2021.
- If you were previously ineligible due to income limits, and your income decreased in 2021, you may now be eligible to receive a full or partial credit on your 2021 taxes.
- If your income *increased* in 2021 to the point where you would have been ineligible, you <u>may have to pay</u> back any funds received to date.
- The Advance CTC payments are **non-taxable income**. Do not include with any income tallies.
- The 6 monthly full amounts paid were \$300 (\$1,800 total) for each dependent child aged 5 years or younger (as of Dec. 31, 2021) as listed on your 2019 or 2020 tax return; or \$250 (\$1,500 total) for each dependent child aged 6-17 years (as of Dec. 31, 2021) as listed on your 2019 or 2020 tax return.
- If your child was born in 2021, you will receive the total CTC of \$3,600 as a refundable credit on your 2021 tax return, unless you opted in to receive some or all of the monthly advance payments during the year.
